LEGISLATIVE & POLICY UPDATE





RESIDENTIAL TENANCIES AMENDMENT ACT

- Rent increases limited to once every 12 months
- Ends 'no-cause' terminations of periodic tenancies justified reason required
- Fixed term leases become periodic upon expiry
- Ban on solicitation of rent bidding
- Allows minor changes to home by tenant
- Increased financial penalties for violations
- Tribunal successful parties can have details anonymised



HEALTHY HOMES STANDARDS

- Sets minimum requirements for insulation, heating, ventilation, draught stopping, and moisture/drainage
- I December 2020: deadline for landlords providing a compliance statement
- I July 2021: private landlords must comply within 90 days of any new/renewed tenancy



MBIE 'BUILDING FOR CLIMATE CHANGE' PROGRAMME

- Holistic review of Building Code/Building Act
- Focus on reducing emissions during construction/ operation and preparing buildings to withstand climate change
- "Will make homes warmer, drier, better ventilated, and provide a healthier place for us all to work and live"
- Initial focus on new buildings
- Consultation/engagement continuing 2021



BUILDING FOR CLIMATE CHANGE: 2050 VISION

- NZ's buildings are using as little energy and water as possible. They are warmer, drier and better ventilated, and provide a healthier place for us all to work and live.
- The wellbeing of NZers has improved, they're leading healthier lives, and respiratory illnesses from cold and damp houses is uncommon. People also have more money in their pockets due to lower energy bills.
- Also: reduced stress on electricity grid, carbon costs/budget a core consideration, reuse/recycle of building materials for circular economy supported by local supply chains

- Commerce Commission has issued a draft decision on Aurora's application for a customised price-quality path (CPP) for lines charges
- Addresses capital replacement to correct decades of underinvestment and ensure safety of infrastructure

BLUESKIN ENERGY LIMITED -OTAGO HOME RETROFIT PROJECT

- \$2.5m funding secured from Central Government
- Project involves a comprehensive upgrade of homes for at least 300 low-income/vulnerable Otago residents
- Feb 2021 planned launch, 2.75 year duration
- Will allow a systematic evaluation of a pilot programme to relieve energy hardship, reduce energy demand and mitigate carbon emissions



NEW – WARMER KIWI HOMES HEATING SUBSIDY TOP-UPS

EECA Warmer Kiwi Homes provides grants for heating appliances to eligible households:

90% of cost up to \$3000 max

Cosy Homes Trust has just introduced a matching grant to compliment the EECA funding:

10% of cost up to \$300 max

= \$3300 total subsidy available across Otago*
